## 2026 REGISTRATION POLICIES

- Upon registration, your child's camp spot will be held with a non-refundable of **\$20 per week per child** applied toward their tuition.
- You may elect to pay the entire balance at the time of registration, or pay in installments throughout the spring (charged on the 15<sup>th</sup> of each month). **All tuition must be paid in full by May 15, 2026.** After that date, all camp registrations (if spots remain) require full payment at time of registration.
- All registrations are subject to availability of space within session and age groups.
- Campers are grouped by grade they will enter in **Fall 2026**. There may be groups that will be of mixed ages.
- Camp scholarships are available. Please contact Executive Director Craig Neuman for the scholarship forms ([cneuman@sestl.org](mailto:cneuman@sestl.org)).

**All scholarship request forms are due by March 6, 2026.**

- In order to complete your camp registration as a Shaare Emeth member, all member families must be current in their financial obligations to the Temple. This includes Member Responsibility, building fund, and any other outstanding charges. An approved payment plan for any outstanding temple fees will satisfy this requirement. To discuss a payment plan, please contact Executive Director Craig Neuman ([cneuman@sestl.org](mailto:cneuman@sestl.org)).
- Payments will be made through your secure CamplnTouch account by either credit/debit card or e-check. A 3% processing fee will be added to all credit card transactions. Debit and e-check transactions do not incur a processing fee.
- Sign up for 8 weeks and save 5% off total tuition; Sign up for all 9 weeks and save 10% off total tuition
- 8- and 9-week tuition discounts do not apply to pre- and post-care or catered lunches

## CHANGING WEEKS, CANCELLATIONS, AND REFUNDS

We are happy to assist you in any changes you need to make to your camper's registration, and we appreciate as much notice as you can give us. Changes to registered weeks will be honored only if staffing is able to accommodate additional campers in a certain group. We will do our best to accommodate your needs.

All requests for changes to enrollment weeks or cancellation requests must be in writing by emailing Camp Director Laura Horton ([LHorton@sestl.org](mailto:LHorton@sestl.org)).

### Cancellation requests sent on or before May 15, 2026:

- Cancellation of all registered weeks: All monies will be refunded less total deposit
- Cancellation of individual weeks: No penalty. All monies for those individual weeks will be applied to remaining balance
- If your tuition was based on the discounted 9-week or 8-week rate and you withdraw your child from camp weeks, your tuition will be recalculated on the number of weeks your child will be attending.
- When issuing refunds to a credit card, the 3% credit card processing fee will not be refunded.
- No prorated or full refund shall be permitted if your child leaves before the end of the session for which they have been registered. We do not offer partial payment for days missed, including illness.
- No refunds will be issued after May 15, 2026 for voluntary cancellations and/or changes to enrolled weeks
- Cancellations for camp due to major medical reasons must be accompanied by a written physician's authorization. Refunds (less the applicable deposit) due to medical reasons will be made at the discretion of the Camp Director and/or the Executive Director.

**Note for Vatikim Campers:** Vatikim campers (rising 7<sup>th</sup> and 8<sup>th</sup> graders) must be registered for at least one week prior to the Week 7 overnight trip to Chicago. Campers cannot register for only Week 7 or only Week 7, 8, and 9.
